- To register an animal the owner must be over 18 years of age on the 1st January 2025 and a current member for the year.
- All animals must be 4 years and over before registration with SJI.
- Passports must be issued by a recognised issuing authority.
- A record of winnings must be provided if the animal has competed abroad.
- All horses or ponies must be microchipped before a registration can be completed. If your horse or pony has been registered previously with SJI you can send a copy of the marking sheet in the passport clearly stating the new microchip number, name of the animal and the owners contact details.
- All animals being registered for the first time must have a named passport and be microchipped.
- Ponies must be measured up to and including 8 years of age. Two consecutive SJI measurings are necessary up to and after the age of 8.
- 50% discount for all animals registrations after the 1st September 2025.
- SJI will not process unnamed passports. Naming must be done with the issuing passport authority.
- Name changes in the passport must be done with the issuing passport authority.
- Foreign visitors/riders can only apply once in any calendar year for a maximum of 4 months. Full details of the animal and evidence of approval for the riders national federation are required at the time of registration. Visiting pony riders wishing to compete in Ireland at SJI shows to which they have been officially invited by the show organising committee may compete in pony competitions for which they are eligible under SJI rules.
- All memberships run from the 1st February 2025 to 31st January 2025.
- New members under the age of 18 years must enclose a legible copy of their birth certificate or passport.
- Athletes must be in their 6th year minimum to become a member of SJI.
- Athletes wishing to compete in Amateur competitions that were not registered as an Amateur in the previous year must submit an official Amateur application form for consideration of the National Amateur Committee. The form is available for download on the website or can be requested by contacting the SJI office.
- Please note that no hard copies of documents are required as digital copies are acceptable.
